AGREEMENT

The college has decided to provide the technical assistance and expert guidelines to Extract and conduct antibacterial analysis of plant extract. The college represented by the principal shall sign this agreement to maintain close liaison and co-operation for facilitating the research work. The service shall cover technical advice, assistance, and research facilities relating to research work.

The other terms and conditions shall be as follows:

1. The samples for the study will be provided by the Institution (Mar Baselios Dental College)
2. The following parts of the project work will be performed in the college
 1. Extraction of plant sample
 2. Plating of root canal sample
 3. Purification of isolate
 4. Antibacterial testing of isolate against one plant extract
 5. Presumptive identification of bacterial isolates by biochemical tests only
3. Fee structure analysis

The analysis fees per sample (per isolate or per extract) will be as under

Parameter 1 - Rs 2000/-

Parameter 2-4 - Rs 500/-

Parameter 5 - Rs 1000/-

4. The names of the additional co-authors, depending upon their contribution in the research work, may be decided by mutual consent between the College and the Institution.
5. The MoU shall be valid for a period of 1 year from this date and can be renewed further on mutual consent.
6. The College shall have full powers to review the project and if the College come to the conclusion that the running of the project is not satisfactory, the College is entitled to disassociate itself from the programme.
7. The outcome of the analysis, if worth publishing shall be realised jointly by both the parties.
8. Amendment to the MoU
During operation of the agreement, if in the opinion of the both the parties, some alteration or modification of the MoU is considered essential, these may be mutually discussed and agreed upon in writing.
